Appendix

- 1) In clause 1, after the definition of Appraisal Term, insert:
 - a) ""Controlled Place" has the meaning given to it in s.17(3) of the Act".
- 2) In clause 1(3):
 - a) after the words "regulation 1", insert "or in the Act"; and
 - b) after the words "that regulation", insert "or by the Act".
- 3) In clause 2(1):
 - a) in sub-paragraph (b), after the words "conditions of that permit," omit the words "use that site for the storage of" and insert "store".
 - b) after sub-paragraph (b), insert:

"; and

- (c) to establish and maintain installations for these purposes."
- 4) In clause 2(2):
 - a) omit the words "in the Licensed Area".
- 5) In clause 5:
 - a) in paragraph 1:
 - i) before the words "the Licensee", insert "During the Appraisal Term, subject to the terms and conditions of this licence":
 - ii) after the words "the following activities", omit the words "within the Licensed Area during the Appraisal Term"; and
 - iii) in sub-paragraph (a), after the words "injection of carbon dioxide)", insert "within the Licensed Area".
 - b) in paragraph 2:
 - before the words "The Licensee", insert "During the Operational Term and the Post-Closure Period, subject to the terms and conditions of this licence and of any Storage Permit granted under it,";
 - ii) after the words "the following activities", omit the words "within the Licensed Area during the Operational Term";
 - iii) in sub-paragraph (a), after "of the Act" add "(including, for the avoidance of doubt, any ancillary monitoring)"; and
 - iv) in sub-paragraph (b), after "exploration", insert "within the Licensed Area".
- 6) In clause 9(1), after "in respect of a", add "storage".
- 7) After clause 11, insert new clause 11A:



"Relevant Works

11A—(1) The Licensee shall not erect or carry out any Relevant Works in a Controlled Place, either in the Licensed Area or elsewhere, for the purposes of the storage of carbon dioxide within section 17(2)(a) of the Act in the Licensed Area except in accordance with a plan to which the Minister has given consent or in accordance with a programme which the Minister has approved.

- (2) The document in which that consent is given may be a storage permit.
- (3) The document in which that consent is given may specify—
 - (a) any conditions to which the consent is subject; and
 - (b) a period to which the consent is limited.
- (4) In this clause, "Relevant Works" means any structure and other works (of any kind) which are intended by the licensee to be permanent and are neither designed to be moved from place to place without major dismantling nor intended by the Licensee to be used only for exploration for places suitable for the storage of carbon dioxide."
- 8) At Schedule 2, replace the current description of the Licensed Area with the following: Licensed area: The area bounded by straight lines joining the following coordinates:
