- (A) On 3 May 2022 the Oil and Gas Authority granted Carbon Dioxide Appraisal and Storage Licence CS006 to BP Exploration Operating Company Limited and Equinor New Energy Limited (the "Licence");
- (B) The OGA and the Licensee are the current parties to the Licence; and
- (C) The OGA has agreed with the Licensee that the Licence shall be varied as follows.

NOW THIS DEED WITNESSES THAT:

- With effect on and from the Effective Date, Schedule 4 to the Licence shall be amended as follows:
 - a) in paragraph 4.1 delete "1 November 2025" and replace with "1 August 2026";
 - b) in paragraph 4.2 delete "1 November 2025" and replace with "1 February 2027";
 - c) in paragraph 5.1 delete "1 February 2026" and replace with "1 May 2027";

- d) in paragraph 6.1 delete "1 September 2026" and replace with "1 February 2028"; and
- e) in paragraph 7.1 delete "1 November 2027" and replace with "1 August 2029".
- This Deed may be executed in any number of counterparts with the same effect as if the signatures on the counterparts were a single engrossment thereof PROVIDED THAT this Deed shall not be completed until each party has signed a counterpart.
