- DaRT and WDSG are NSTA-led/chaired and are formally part of the wider North Sea Task Force, with the majority of other groups being OEUK-led/managed
- OEUK produce a 'Quarterly Decommissioning Dashboard' which provides an overview of Task-Finish group updates (which they coordinate), upcoming events, and general/network updates
- OEUK also lead an 'Offshore Wind Decom Network (OWDN)', 'Decommissioning Technical Project (DTP) 'Decom TFG Liability in Perpetuity' – Ricky Thomson (OEUK Decom Manager) is focal point for these, and the other OEUK groups listed
- Likely to be areas of potential overlap or alignment between the groups, with discussion required on how best to have visibility of the objectives, priorities and key tasks across them, to maximise value/efficiency
- DecomMission and OEUK both run various webinars and workshops for the Decom sector in UKCS – DM are focused on supply-chain specific, whilst OEUK typically prioritise the operator groups
- The OEUK Task Finish Groups (TFGs) that are currently active are included on the slide, but others do exist
- Collaboration groups do exist (i.e. Subsea Decom Collaboration (SDC, NSTA-initiated) and SNS Operators looking at re-use/re-purposing opportunities (EEEGR-SNS)) but are not listed on the slide
- National Decom Centre (NDC) exists and engages with OEUK, DM, NZTC and NSTA and attend / are represented on a number of the OEUK groups
